NYC Nonprofit Solar One Appoints Two New Members to the Board of Directors

She is the Founder and President of Davlin Development Group, raising private and institutional capital for clean energy and resiliency projects in the United States and Europe. For over 25 years, she has led strategic private and public-sector investments in the environment and energy sectors, with a focus on clean energy, environmental security, water infrastructure, and waste-to-value to address climate and scarcity issues. She has worked at the White House, Department of Defense, leading nonprofit organizations, investment firms, and multinational companies.

Solar One is starting 2022 with organizational growth and expansion of its programs clearly on the horizon. Solar One has nearly doubled its staff over the last several years to now include over 40 dedicated green energy, sustainability, and education professionals.
